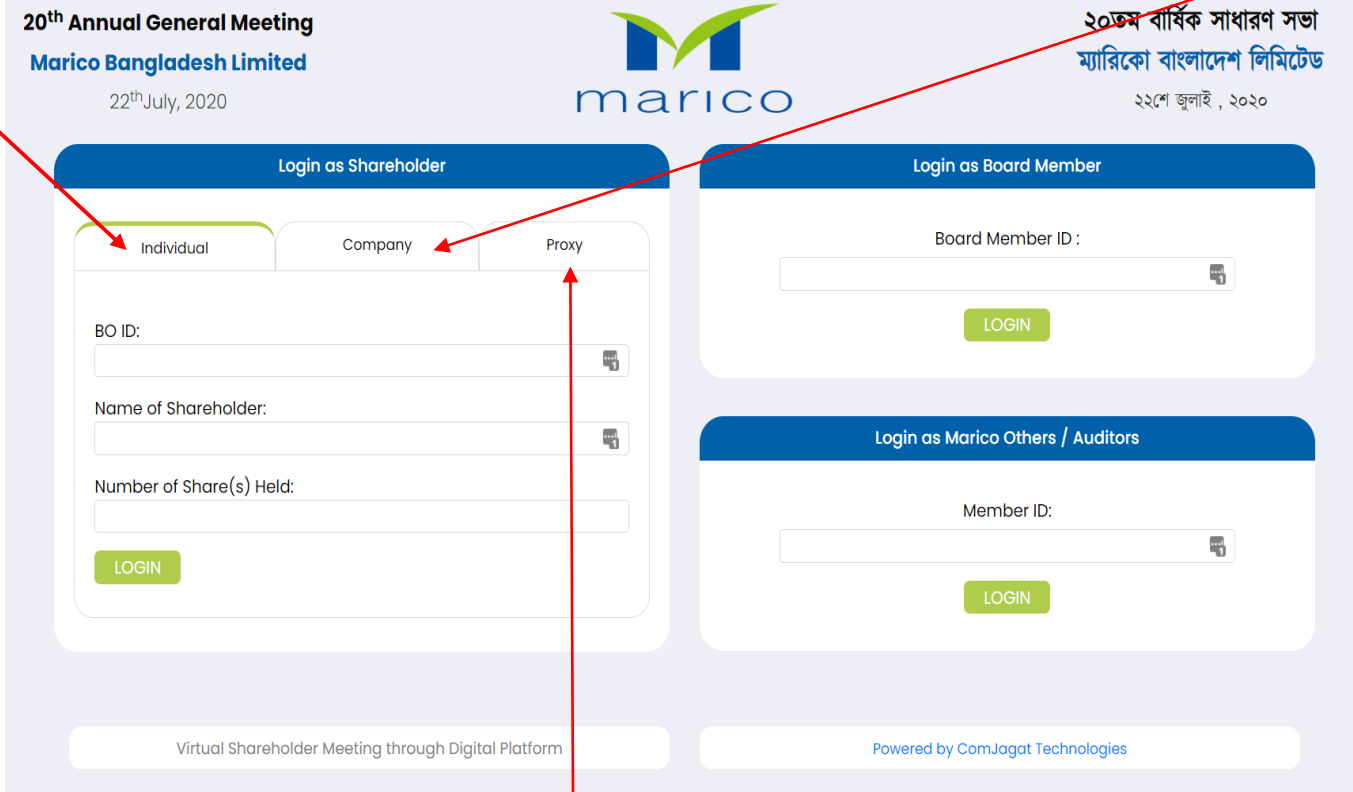

- Mandatory fill up of 3 information: BO ID, Name of Shareholder, Number of Share(s) Held
- All 3 correct Information will allow shareholder to log in.

- Click “Company” button.
- Mandatory Fill up of 4 information: Name of the Company, Authorized Person Name, BO ID/Folio ID, Number of Share(s) Held
- Authorized person name will be the person who will be assigned from the specific company. Multiple BO ID user can give maximum 5 BO ID at a time by clicking plus sign (+) beside the BO ID field. But he has to give the summation of all share that company hold in the “Number of Shares” field.
- All Correct Information will allow a Company shareholder to log in

- Click “Proxy” button
- Mandatory fill up of 4 information: BO ID/Folio ID, Name of Shareholder, Number of Share(s) Held, Name of Proxy
- Correct Information will allow a Proxy shareholder to log in
