Musk & Mumbai debut: Tesla's 1st store on Jul 15

Deliveries likely to begin from first week of August

'India', 'July 25' and a Tesla logo were enough to take Instagram by storm on Friday ahead of the automobile multinational's India entry. Through social media teasers and invites to influencers and celebrities, the Elon Musk-led electric vehicle major has announced the launch of its first India showroom, in Mumbai, on July 15. The showroom is being dubbed an 'experience center'.

Tesla will compete with its Chinese rival BYD, as well as domestic major Tata Motors in the Indian EV market.

From sending exclusive invitations to select media editors and influencers, to sightings of the Tesla Model Y on Indian roads, viral social media posts about the event, and speculation about Elon Musk's possible presence, the secrecy surrounding the Tesla launch has created anticipation and hype.

According to an invite about the event that *Business Standard* got access to, the 90-minute launch event for the Tesla "Experience Center" will take place next week at the Maker Maxity Mall in Bandra Kurla Complex in Mumbai.

Sources said that after Mumbai, the company is likely to open another showroom in Delhi later this month. The deliveries of cars to customers is expected to start from August, sources added.

According to industry sources, along with the Experience Center launch in Mumbai, the company

may officially launch direct sales to Indian customers.

According to sources, the public relations mandate for the Mumbai event was given to Gurugram-based brand consultancy and PR firm Laudco Media.

Tesla and Laudco did not respond to questions from *Business Standard* at the time of going to print.

According to media reports, its first offering for Indian customers will be the Model Y, which is the world's largest-selling electric car.

According to plans, it is likely to be imported from China in completely built-up (CBU) form.

The Tesla Model Y is available in two variants — rear-wheel drive (RWD) and long-range all-wheel drive (AWD) — with a price expected to start from around \$56,000 before

taxes and insurance, as per media reports. Moreover, since there were reports of the car being spotted on roads, it indicates that it will be the first product in the Indian market, with some reports naming the Model 3 along with it.

Though Tesla has been trying to enter the Indian market for some time, it has also been seeking sops for manufacturing and imports from the central government. In June, India's Minister for Heavy Industries, HD Kumaraswamy, confirmed that the global major is not keen on manufacturing in India.

Last month, *Bloomberg* reported that five Model Y units arrived in Mumbai from Tesla's Shanghai factory. The cars were declared at \$31,988 and attracted import duties of around 70 per cent.

In the Indian market, a major challenge for Tesla will be the import duties of 70 per cent on electric vehicles, as the ex-showroom price of the same models in the US is around \$44,990.

Restaurants cheer, traders frown as Delhi govt mulls keeping shops open 24x7

As the Delhi government reportedly mulls permitting shops and markets across the city to remain open round-the-clock, trader associations say the move will help business, but perhaps only marginally, as they may not get as many customers in the late hours as they do during the day.

Some restaurant owners said such a policy will help drive revenue growth as people may venture out instead of getting food delivered. However, retailers flagged the financial impact, saying cost of operations may rise for keeping shops open 24x7, which is unlikely to get compensated if footfalls are minimal at night. Some also highlighted the need for better policing to ensure safety of customers, who may venture out in the late hours.

"We don't see people in the shops during the day itself as a lot of them are now shopping online. We don't see this reversing in the night, also because people wouldn't feel safe shopping at night. But

for some smaller traders and even eateries, this could turn out to be a boon," said a member of a South Delhi market association on condition of anonymity.

Trader associations further highlighted the need to improve the law and order situation in the city to make this change a success.

"While it is the government's decision, there are a lot of steps that need to be taken before such a policy can be implemented in the city, with the biggest roadblock

being the law and order situation in the national capital," said Atul Bhargava, president of New Delhi Traders Association (NDTA).

The NDTA includes traders from the 14 blocks of inner and outer circle in Connaught Place, Regal and Rivoli buildings, Scindia House, and Old Janpath market.

Bhargava pointed out the presence of "illegal hawkers", which will go up if the operational hours are extended.

"To ensure smooth operations, the government will have to ensure enough police personnel are present in the night, so that people feel safe enough to step out in late hours," Bhargava added.

Echoing similar sentiments, Sanjiv Mehra, president of Khan Market Traders Association, said that extended hours could lead to an increase in hooliganism on the streets. He said that the new policy, if undertaken, will lead to increasing costs for establishments.

"Not just for the safety of people, a lot of shops will end up paying more for electricity and additional labour costs, even though we believe that footfall will not increase dramatically in the night," Mehra added.

He pointed out that the move could lead to exploitation of labour as owners might not make space for an extra shift and make employees work for longer hours.

However, restaurant owners have welcomed the thought, stating that while people might not step out to shop at night, they will definitely step out to eat.

ONOE Bill does not violate Constitution, say ex-CJIs

Former Chief Justices of India (CJIs), D Y Chandrachud and J S Khehar, on Friday flagged certain provisions of the constitutional amendment Bill for simultaneous elections, including powers it vests with the Election Commission, but rejected the suggestion that the idea falls foul of the Constitution, sources said.

Khehar is the third ex-CJI to question the wide leeway the Bill confers on the poll body under its 82A(5) Section in deciding on holding the election of an assembly after Ranjan Gogoi and Chandrachud.

While Chandrachud appeared before the Joint Committee of Parliament, he had submitted his written opinion earlier.

Summarising the views expressed by the two jurists on what has come to be known as the One Nation, One Election (ONOE) Bill, a source said both of them suggested that the bill has certain grey areas that should be addressed by the committee and made some suggestions as well.

He added that both of them made it clear that the

proposed law does not violate the basic structure of the Constitution, as alleged by opposition parties. "It does not hamper the basic structure of the Constitution," Chandrachud is learnt to have said.

Opposition members, including Priyanka Gandhi Vadra of the Congress, raised queries about the constitutionality of dissolv-

ing assemblies midway to synchronise their polls with Lok Sabha elections, sources said.

Khehar, they added, suggested that Parliament or the Union Council of Ministers should have a say in taking the call on holding the election of an assembly, as envisaged under the 82A(5) section of the Constitution Amendment Bill. PTI

Widows: The double stigma

The Padma Bhushan awardee and activist Dr V Mohini Giri once remarked that "widowhood is a state of social death", an observation that succinctly summarises the realities facing widows, including my mother, the world over. Why oppressive measures against widows are followed so reverentially is something that the Emeritus Professor of Intercultural Literary Studies, University of Leiden, Mineke Schipper, dissects in *Widows: A Global History*.

The eight chapters of Schipper's magisterial work offers a deep understanding into such issues as the kind of grieving is considered acceptable for a widow, what clothes are appropriate, to what extent she must desexualise herself, and if she can claim any right on the property of her deceased partner.

The author's work in the domain of oral history also informs *Widows*. In fact, the idea came to her while working on a previous volume titled *Never Marry a Woman with Big Feet: Women in Proverbs from Around the World*. At the time, Schipper reflected, which she recollects in the Acknowledgments section: "A widow was associated with death — and a widower was not. There must be more to widowhood, and I promised myself to get back to it later."

All thanks to her for keeping the promise. The sheer scale of the stories, the range of historical evidence, and the way Schipper articulates the injustices that widows endure make it a worthy successor to the seminal work on widows by Margaret Owen's *A World of Widows* (1996), chiefly covering "poorer communities" in Africa and Asia. Schipper's work ties well the customary idioms of widowhood with the neopatriarchal othering they face. Sample this Chechen saying: "Death of your wife, replacement in bed." Or this one, which is popular in Europe: "Grief for a dead wife lasts to the door."

Schipper notes the role language contributes towards creating the image of a widow. The word *vidua* in Sanskrit "means destitute, and the Latin *viduata*

(made destitute, emptied) is the root of the word for [a] widow in many European languages," she writes. The image is strongly adhered to by society if a widow happens to be in a patrilineal setup, which "creates greater inequality between marital partners".

Schipper also highlights "traditions [that] force widows to live in isolation for several months", underlining how compulsory isolation in some societies can "take on more extreme forms" — such as in India because of the caste system. In the chapter titled "Mourning," Schipper weaves in famous reflections on grief such as Joan Didion's *The Year of Magical Thinking* (2005). Didion's memoir of her husband John Gregory Dunne's death is popular because of the radical way in which she processes grief. Juxtapose this with the complete lack of agency for traditional widows in expressing their loss.

Examples include the "Rudaali" tradition in many parts of India, and the title of "head mourner" a widow earns in Trobriand Islands. A widow's grief was closely tied to

what ornaments they'd wear. In the book, there's a picture of a Dayak widow in mourning, captured in 1900 in Indonesia. Schipper writes, "The more rings worn, the heavier the burden, and as a result the greater your prestige." Then, there was also a practice in the Andaman Islands of today's India to carry the remains of the deceased, say, a skull, as a photograph by SL Hamilton reveals.

Suicide and sati practice are discussed in "Accompanying Your Husband in Death". In the chapter titled "Sex", Schipper notes how South Asia leads in producing the number of child brides (and widows), and in "Suspect of Witchcraft", she articulates the kind of accusations a widow must brave. "The most problematic obstacle for the rights of widows in less-well-off regions is the unfortunate combination of illiteracy, fear of witchcraft and covetous in-laws," she writes. Some revered texts make things worse: *Manusmriti*, for example. But the way a widow's sexual desire is kept in check is a deeply problematic practice that's most strictly observed to date even in many educated households. For example, in some societies, to maintain the "bloodline", a widow may be married to her brother-in-law. In others, "ritual sex" is mandatory. Shockingly, no one labels it for what it is: rape.

Schipper observes that things are changing, but slowly. Some support systems are pushing back against traditions, for example, the Widows Alliance Network (WANE) in Ghana or the Barefoot College in Tilonia, Ajmer where widows from Africa come to upskill themselves. The iconic photograph of widows in Vrindavan celebrating Diwali is a case in point, too. But one must be cautious about rejoicing in these optics, as several detailed interviews from this book reveal. Coupled with accessible storytelling, academic findings and photographic evidence of how widows across centuries and geographies have lived — and continue to do so today — *Widows* makes for an important read as a reflection of the state of women's rights in 21st century India.


