Mr. Chaitanya Jaikishan Panchal, a Member of the Promoter Group, sold 75000 equity shares, by way of market sale during the reporting quarter. 4. Ms. Hema K Mariwala, Ms. Priyanjali Mariwala, Ms. Preeti Gautam Shah and M/s. Harsh Mariwala Enterprises LLP, members of Promoter Group, have NIL shareholding in the Company.
